responsible ASN or the Organiser or its representatives or Associated Bodies or their representatives; or any other negligence or lack of reasonable care by the ASN or its representatives or the Organiser or its representatives or Associated Bodies or their representatives or me, in each case arising in connection with my participation and attendance in this event; and I agree, in consideration of the *Organiser* accepting my entry to the event, that I waive any rights and/or claims, agree to release, hold harmless and not to sue the Organiser and its representatives and any Associated Bodies and their representatives in relation to any liabilities, costs, expenses, damages and losses referred to in this Declaration. To the fullest extent permitted by *Applicable Laws*, this Declaration shall be binding on me and my heirs and successors in title and is not limited to nor affected by any other release and/or indemnity granted by me to whomsoever.

5. I understand that it is my full responsibility to comply with any obligations or duties in relation to health and safety which are placed on me under any *Applicable Laws, FIA Regulations* and/or *ASN Regulations*, in relation to my participation in this event.
6. If I am injured during the event, I hereby expressly authorise all medical treatment, rescue operations, arrangement for my transport to hospital or other emergency measures which the personnel appointed by the *event Organiser* may in their absolute discretion consider necessary for my well-being and I undertake to pay all costs associated therewith if necessary.
7. I fully understand and accept that: The *Organiser* and Associated Bodies assume no responsibility in relation to providing suitable insurance cover in relation to all of the risks arising from my participation in the event, unless otherwise required by local laws or otherwise explicitly written in the Supplementary Regulations of the event.
